<b>Reports/New Business</b>	<p>Jamie reported for Bristol Regional Medical Center. She reported that TPA has been administered 51 times this year with 78% of those being below the 60 minute window. She also reported she has been doing some education with local EMS agencies on the CSTAT scale. She reported the education has been well received.</p> <p>There was no report for Johnston Memorial Hospital.</p> <p>Carla Gunter reported for Twin County Regional Hospital. She reported they had their stroke survey in October and had 4 recommendations for documentation measures. They are already working to improve those areas. Carla reported TPA has been administered 23 times this year. Carla also reported Twin County hosted the ASLS course and had 7 EMS providers attend. Carla also said they implemented a new protocol in September which uses a stroke code up to 4 hours, the 4-24 hour window gets a Dawn alert.</p> <p>Cody Jackson reported for Wings Air Rescue. He reported that during the first quarter after the CSTAT implementation they had some issue with it being documented, by the third quarter they are seeing a lot of improvement with that and nearly all CSTATs are being documented. The issue is being fixed and they are seeing much clearer documentation now.</p> <p>There was no report for Ballard One.</p> <p>There was no report for Holston Valley Medical Center.</p>
